- 14 & Under – may start as early as Tuesday, July 10th thru Monday July 16th

However, Rec-league all-star teams who also may play in travel tournaments are allowed, as well as kids who play on travel teams, as long as the players that make up a team entered are the same ones' who have played in at least half of their rec-league team's scheduled games."
